

Latex Knowledge Center Newsletter Draw (“Draw”) Terms and Conditions

1. This Draw is promoted by HP Printing and Computing Solutions, S.L.U., Camí de Can Graells 1-21, 08174 – Sant Cugat del Valles (Barcelona) (“Promoter” or “HP”).
2. All entrants to the Draw must be aged 18 years or over at the date of entry and comply with any further eligibility requirement set out in these Terms and Conditions. Employees of the Promoter, their families, agents or any third party directly associated with administration of the Draw, are not eligible to enter into the Draw.

By entering the Draw, you confirm you are eligible to participate and claim the prize (if you win) and doing so complies with your organization’s or company’s internal policies (if applicable). HP may require you to provide proof that you are eligible to enter the Draw. Employees or representatives of government or public sector entities or organizations are not eligible to participate.
